WHEREAS the Albertan youth unemployment rate is nearly double the provincial average¹;

WHEREAS the cost of attaining a post-secondary education has significantly risen above inflation²:

WHEREAS the cost of post-secondary education stands as a serious obstacle in accessing the post-secondary education system;

WHEREAS individual's from rural, aboriginal, and lower socio-economic backgrounds are underrepresented in the post-secondary education system³;

WHEREAS private sector companies receiving a wage subsidy from a student employment program may still pay student employees the minimum wage⁴;

WHEREAS student employment programs should be geared towards advancing skills learned in study;

WHEREAS Alberta is one of the only provinces in Canada without a student employment program;

BE IT RESOLVED THAT the Students' Union will advocate for the reestablishment of a provincial student employment program and increased government funding towards federal student employment programs;

BE IT FURTHER RESOLVED THAT the Students' Union will advocate for provincial and federal student employment programs to be in operation throughout the year;

I.CAPITAL PROJECTS

WHEREAS the University has numerous sources of revenue and should not depend solely on students to finance capital projects;

WHEREAS the University should not be spending tuition revenue on capital projects;

WHEREAS as capital projects benefit the University and serve a wide range of communities beyond undergraduate students;

WHEREAS there should be consultation with students as to the creation, use, and termination of student fees:

BE IT RESOLVED THAT tuition revenues shall not be used to fund capital projects;

BE IT FURTHER RESOLVED THAT a dedicated student fee for a capital project shall not be used to fund the construction of academic or research space;

BE IT FURTHER RESOLVED THAT the Students' Union shall participate in defining the purpose and scope of any project where a student fee is involved;

BE IT FURTHER RESOLVED THAT all capital projects funded directly by a student fee dedicated to that project must include proportional commitments from other stakeholder groups;

BE IT FURTHER RESOLVED THAT a dedicated student fee for a capital project shall not be implemented until such a time as students have the ability to receive benefits from their contribution;

BE IT FURTHER RESOLVED THAT any capital project funded directly by a dedicated student fee shall have a governance structure that includes adequate student representation; and

BE IT FURTHER RESOLVED THAT any dedicated student fee that funds a capital project shall be eliminated upon the final payment of the agreed upon student contribution.

XX.SUSTAINABILITY

WHEREAS the University has long recognized the influential position of the institution in addressing issues of sustainability, including social justice and environmental management;

WHEREAS energy efficiencies resulting from investment in viable alternatives yield long term benefits to the University WHEREAS; investing in a safe, inclusive, and diverse community that is supported by social services and programming yields long-term benefits to the University;

WHEREAS the University is expanding its capacity to create its own <u>local energy</u> solutions

with the School for Energy and the Environment;

WHEREAS integrating sustainability topics into course curriculum is a very practical way for the University to participate in global sustainability practices;

WHEREAS students who are actively engaged in sustainability initiatives and education are more likely to live, and encourage others to live, a sustainable lifestyle in the future;

BE IT RESOLVED THAT the Students' Union shall encourage the University to develop innovative solutions to environmental, economic, and social justice issues through all of its faculties and departments; through the School for Energy and the Environment;

BE IT FURTHER RESOLVED THAT the Students' Union shall advocate to the University for the continued <u>reduction of its environmental impact, and adherence</u> to the highest <u>environmental</u> standards <u>of tolerance and inclusivity</u>, reflective of the diversity <u>of it's student, staff, and faculty in its operations</u>;

BE IT FURTHER RESOLVED THAT the Students' Union advocates for the inclusion of topics in sustainability, including all three pillars of society, economy, and environment, in course curriculum where appropriate; and

BE IT FURTHER RESOLVED THAT the Students' Union seek to actively engage the student population in sustainability initiatives and education.

19.. The Social and Environmental Responsibility Committee (SERC)

- (1) The Social and Environmental Responsibility Committee (SERC) will become a subcommittee of the Students' Union Executive Committee with the mandate to:
- (i) Aid the Students' Union in its ongoing efforts to be socially and environmentally responsible in the administrative, political, and business arenas.
- (ii) Help promote the organization as a leader in economic, environmental, and social sustainability as aspired to in the Students' Union's Strategic Plan 2011-2014 by offering consensus based recommendations to the SU Executive Committee
- (iii) Provide tools for the Students' Union to serve as a model example of global citizenship for students, the University, and the broader community in a rapidly globalizing world.
- (2) The terms of reference will be annually reported to Students' Council.
- (3) Reports will be provided to Council every trimester.
- 4920. Conflict-of-Interest
- (1) No person shall use a Students' Union position that he/she holds to further personal business interests.
- (2) No person may hold a Students' Union position who100 (17)
- (a) is party to any contract or agreement with the Students' Union, excepting contracts or agreements directly relating to that person's employment by the Students' Union; or
- (b) has any interest in a contract or agreement with the Students' Union, excepting contracts or agreements directly relating to that person's employment by the Students' Union.
- (3) Does not apply to any person by reason only
- (a) of the receipt of any properly-approved honorarium, commission, or allowance from the Students' Union;
- (b) of being a non-executive member of any registered student group which has any contract or agreement with the Students' Union; or of the sale of goods or services to the Students' Union in the ordinary course of business, at competitive prices, and in accordance with Students' Union procedures.
- (4)No member of Students' Council shall vote on a motion relating to a student group or organization of which he/she is a member unless that organization is a faculty association.
- (a) Membership in an organization shall be defined as
- (i) regular meeting attendance and voting and/or speaking privileges at meetings; or
- (ii) holding office within that organization
- (5) If a councilor has a conflict of interest and votes on a motion in Students' Council or any one of its standing committees
- (a) they will report that immediately to the Speaker of the Association
- (b) if unreported, any member of Students' Council may send a petition to DIE Board within four (4) months or before the conclusion of the session of Students' Council, whichever is longer. Petitions made are subject to Bylaw 1500.
- (6) In extraordinary circumstances a member of council should be allowed to retroactively change their vote to an abstention in the case of a conflict of interest. This would be done through a motion to

Students' Council. Any member of Students' Council will have an option to petition DIE Board on the narrow issue of what constitutes extraordinary circumstances.

(7) Neither any member of the Students' Union Executive Committee nor the Chief Returning Officer of the Students' Union shall apply for a remunerated position with the Students' Union unless the selection of that position is ratified by Students' Council.

210. Nominations to University Bodies

- (1) The four individuals nominated by the Students' Union to the University of Alberta Senate shall be
- (a) the Students' Union Vice President (External), and 100 (18)
- (b) three members of the Students' Union selected by Students' Council, after receipt by the latter of a recommendation from the Council Administration Committee.
- (2) The two individuals nominated as ex-officio representatives of the Students' Union to the University of Alberta General Faculties Council shall be
- (a) the Students' Union Vice President (Academic), and
- (b) the Students' Union Vice President (Student Life).
- (3) The two individuals nominated by the Students' Union to the University of Alberta Board of Governors shall be
- (a) the Students' Union President, and
- (b) the Undergraduate Board of Governors Representative.
- (4) The Undergraduate Board of Governors Representative shall be elected at the same time and in the same fashion as the Students' Union President and Vice Presidents.
- (5) The Undergraduate Board of Governors Representative shall have access to sufficient administrative resources for the discharge of his/her duties.

224. No Force or Effect

Any decision of Students' Council that is in conflict with federal or provincial statute or with the Common Law is of no force or effect.
