Thank you Councillor Kwan for the question. I was asked today at an event what my largest takeaway was from my year as SU President and my answer was simple: Respect.

Whether we are talking about student mental health, international student issues, gender issues, or even tensions with University administration, we always get brought back to the fundamental value of respect.

When we recognize and respect that we have differences in the struggles we endure, the cultures we are brought up in, the identities we carry, the experiences we've lived, and the priorities we hold, we can start to understand differences in actions and opinions.

We state in our oath that "[We] will oppose ideas, not people". As members of Students' Council, we must each be responsible for the debate we are a part of, whether we are participating vocally or as active listeners.

I am just as guilty as anyone else in this room for not stepping in when debate was borderline disgraceful, and I must admit that I underestimated the toxicity of such behaviour. As Lily Tomlin once said, "I always wondered why somebody didn't do something about that, then I realized I'm that somebody".

TL;DR: we must all take responsibility for the tone of the debate as long as we are members of Council, and can ensure respectful debate by 1) role modelling and 2) making it clear when behaviours are considered respectful.





Re: Report to Council for March 24th meeting

Dear Council,

I'm unfortunately unable to attend this meeting since I will be in Abbotsford for the Canadian Alliance of Student Associations (CASA)'s Annual General Meeting. It takes place from March 25-27 but I will be coming back to Edmonton on the morning of March 26th so that I can be at the Legislature during the announcement of the Provincial Budget.

Since our last Council meeting, I've primarily spent my time lobbying. Here's a more thorough breakdown of how I spent my time:

Board of Governors Meeting

I attended my first Board of Governors meeting on March 13th as a guest. It was a very interesting meeting and I enjoyed observing the dynamics in the room. Among the other issues discussed, I was of course very interested in one item – the market modifier proposals. Governor Hansra and President Lau moved to split the motion so that the Board would vote on four proposals together and the Economics proposal separately. Unfortunately, all five proposals passed at the Board, even though the Economics proposal ended in a close 12-9 vote. You can read the Gateway Article for more information.

CAUS Lobby Week

From Sunday March 15th to Friday, March 20th, I spent almost all of my time focusing on the CAUS lobby week. We had over 35 meetings with MLAs including with Minister Scott, Finance Minister Campbell, Minister Kubinec, and Minister Denis to name a few. In addition, we met with all the opposition parties and were introduced in Question Period on Monday. Monday evening featured a social event with the government MLAs, which was very fun.

Throughout the week we also met with a representative from the Alberta Student Awards Personnel Association (ASAPA) – a group of individuals who work in student financial aid offices across Alberta. We typically have very similar lobby goals regarding student financial aid.

I also presented about CAUS to MacEwan's Students' Council. Because they are new members to CAUS it is very important we have a strong presence at their Council level to ensure that everyone feels engaged and that they recognize the strengths and value of CAUS. In addition, I participated in a panel for a class at MacEwan on the topic of market modifiers. Finally, I wrapped up my involvement with Lobby Week by presenting at the NDP budget consultation – they brought together a group of stakeholders from labour to small business to provide input on the budget. I'm eagerly awaiting the Budget to see what's in store for post-secondary.

GOTV

Now that SU Executive Elections and Lobby Con are out of the way, I will be devoting more of my time to getting GOTV up and running. Our marketing materials are looking very good – posters should be up this week. We are working on putting together a team of volunteers to go around and get students signed up to vote. (Please consider helping us! I really need you!)

On Monday, March 23rd, I attended a session for Apathy is Boring (co-hosted by the Peter Lougheed Leadership College and the Students' Union). Research on the topic of youth voter engagement and strategies to increase it were discussed – it was super interesting! CAUS will also be partnering up with Apathy is Boring in some capacity for our upcoming GOTV strategy.

Transition

At the same time as I try and wrap up my projects, I am also preparing for our transition so that I can set my successor up for success. This is likely what my weekends will be preoccupied with.

Coming up

I will be in Abbotsford for CASA on Wednesday and most of Thursday and Friday will be spent responding to the Provincial Budget and understanding the implications for students and post-secondary education. I am scheduled for a conference call with Minister Scott on Friday for this very purpose.

I will also be involved in the hiring process for the new <u>Director of Research and Political Affairs</u> here at the SU and the <u>summer student researcher for CAUS</u>. Please pass on the job opportunities or take a crack at them yourself!

March 13 Board of Governors Meeting

Governor Hansra and myself met with the Board Chair in advance of the meeting to discuss a motion to split the five market modifier proposals. As discussion and debate in the board meeting moved forward, it was clear that the largest (common) dissatisfaction was with the Economics Market Modifier, where became the basket in which we "put all our eggs". With a motion to split the market modifier motion into two (Business MBA, Pharmacy, Law and Rehab Medicine in one, and Econ in the other), we would have had the highest chance of affecting the final outcome.

The debate was clear as water when President Indira Samarasekera summarized the vote: the vote was not simply about the Economics Market Modifier, but whether the bringing in of revenue to the institution would outweigh process and principle. Comments were also made by board members about the fear of rejecting a revenue source during "tough times", as well as not having a clear idea of what a "no" vote would mean.

The final motion for the Economics Market Modifier passed 12-9, and this story became a strong narrative during CAUS Lobby Week of why regulation of tuition and fees is necessary.

Sustainability Plan: Student Health & Wellness Workshop

Participating in the second Student Health & Wellness Workshop of the Sustainability Plan was an inspiring experience. In the first workshop, we ran a visioning exercise of what we would like to see. In the second workshop, we brainstormed obstacles, and followed up with strategies of how to overcome them.

As there was a low student turnout, much of the conversation was focused on the structure of our student services on campus and how to build and strengthen collaboration and communications.

We are looking at running a parallel process (mimicking the workshop) on a weekday evening with targeted invites to students interested in student health, to feed our ideas into the process.



PLLC Collaboration with SU Management and PLLC Administration

Yesterday, General Manager Marc Dumouchel, Senior Manager Student Services Jane Lee and myself had lunch with Dr. Martin Ferguson-Pell and Bobbi Schiestel from the Peter Lougheed Leadership College to discuss collaboration between the SU and PLLC.

One key clarification we made was where the campus community expected the PLLC to be the vision and strategy for our campus ecosystem, the administrators of PLLC saw the PLLC as just another piece of the pie. With this, we plan to create a committee (composition to be discussed) outside of PLLC to set the vision and strategy for student leadership and development ecosystem on campus that will clarify the relationships and interactions between different program providers.

Hi Council,

This report covers from March 10th to March 24th.

Advocacy

- **Student Housing Policy:** A first SU draft is done and being reviewed. Next step is to arrange another meeting with F&O.
- Residence Association MOU: We have finished 3 meetings, now. We are taking a two week hiatus to produce 1) A communications / routing document that articulates what each of our different meetings on residences are for, 2) A document that articulates how Residence Services works with Residence Associations on the day-to-day, and 3) a proposal from each group at the table for how Residence Association fees should be managed. We'll meet next during the second week of April.
- Residence White Paper: The next (nice-looking) draft of the Residence White Paper is done. I'll be taking it for review by Residence Associations once more before looking for signatories and/or bringing it as an information item to council.
- RHA: The RHA conducted its second vote to change its structure. As of April 30th, the RHA will be an advisory committee of the SU and GSA. They also voted to hold their remaining financial assets in trust with the Students' Union. Residence Services and Discover Governance will be working on how Joint Executive Training for Residence Associations will go.
- **Prayer Space:** To provide background again the University is putting forward roughly \$500,000 with students fundraising the remaining amount to build an Interfaith Prayer and Meditation Space where the International Centre currently is. The International Centre is moving to Telus Centre over the summer, at which point construction could begin, with a *tentative* winter 2016 opening for the prayer space. We're likely signing an MOU regarding this prayer space as of Wednesday (tomorrow).

Council and Governance

- COFA MSWG: Last meeting will be on April 1st, where we will talk about how COFA MSWG could change or improve for next year's representatives.
- **Policy Committee:** We have to wrap up the second readings of the policies you have before you today Residence second reading, Health and Wellness second reading.
