2017-05/7a Bill #2 - Joke Candidates - First Reading

CHRISTENSEN/FARRIS MOVE to approve the first reading of Bill #2 - Joke Candidates, on the recommendation of Bylaw Committee, based on the following first principles.

First Principles

- 1. A joke candidates is defined as any candidate who chooses not to use their given name or a reasonable derivative of their given name when appearing on the ballot.
- 2. In the context of Bylaw 2400, it is unclear what happens if a joke candidate were to achieve more votes than a candidate in a race.
- 3. Bylaw 2400 shall be amended to clarify that, if a joke candidate does receive more votes than any other candidate, the joke candidate shall be dropped from the ballot and counting shall continue, with the joke candidates' ballots being redistributed in accordance with normal conventions for SU elections.
- 4. In the context of Bylaw 2200 and 2300, a joke candidate may become a real candidate within 48 hours of being designated a joke candidate.
- 5. Bylaw does not currently stipulate when a person is designated a candidate.
- 6. Bylaw 2200 and Bylaw 2300 shall be amended to state that a person becomes a candidate at the nomination deadline.
- 7. Bylaw 2200 and Bylaw 2300 shall be amended to state a joke candidate may become a real candidate within 48 hours of the nomination deadline.

Goals

STRIDE




Closing Remarks

Hi Council,

The last couple weeks have been a whirlwind for me. Asides some personal developments, I have been largely in the office, which has seen me try and get a lot of internal projects, research, and meetings done.

Mid Year Managers Meeting

The Executive and I spent the day at our mid-year manager's meeting last Friday, and I found it to be incredibly useful. There were still a few folks I had not met, as well as some student employees, in the room, which made for some great discussions. The executive and general manager gave updates and so far it looks like we are ready to have a fantastic year.

Council of Alberta University Students (CAUS) - In Person Meeting

I chaired my first full in-person meeting for CAUS this Monday in Calgary, and overall it went well. We have selected our research direction for the year, the international student experience in Alberta, adopted new communications and travel policies and set our meeting times for the rest of the year. I will have two sessions of importance coming up on behalf of CAUS; 1st a meet and greet with the Advanced Education Ministry and 2nd a Funding Framework Review meeting. Mental Health Funding Announcement



Minister Marlin Schmidt Making Announcement

By far the biggest news of the week was the announcement regarding mental health funding for post-secondary institutions. This portfolio has been a priority for many student leaders over the past few years, mainly since the first funds were announced in 2013.

I can confidently say that the announcement was good news, for UASU members and students across the province. A short version of the wins:


- Increase in funding from 4.6 million province wide to 8.9 million in first year (increase in funding a UASU & CAUS advocacy priority for over 3 years)
- 25.8 million to be allocated over 3 years (sustainable and long term funding a UASU & CAUS advocacy direction over past 3 years)
- No decrease in existing services
- Focus on collaboration with Alberta Health Services to create an integrated and long term system for campus mental health (better triaging and supports for students everywhere)
- Funding Healthy Campus Alberta Community of Practice
- Reviewing Student Aid Policies to "better support students experiencing mental health concerns"
- Granting opportunity for Indigenous post-secondary students mental health.
- 24 hour virtual care

Improving Post-Secondary Mental Health

Post-Secondary Student Mental Health

Albertans deserve a government that makes life better. The Government of Alberta is improving things that make a difference in Albertans' lives like ensuring mental health supports are accessible and available when post-secondary students need them.

Student mental wellbeing is linked to academic achievement, learning, retention and future success.

In 2016, ten Alberta post-secondary institutions participated in the National College Health Assessment survey to better inform their health and wellness programming.

The survey highlighted, over the past 12 months:

- 57.5 per cent of students felt hopeless.
- More than 90 per cent felt overwhelmed.
- 65 per cent felt very lonely.
- More than 42 per cent felt so depressed it was difficult to function.
- Almost 64 per cent felt overwhelming anxiety.
- 13.1 per cent seriously considered suicide, and 2.1 per cent attempted suicide.
- 18.9 per cent had been diagnosed or treated by a professional for anxiety and 15.4 per cent for depression.

Mental Health funding

The global amount provided last year was \$4.2 million. This included funding to the University of Alberta, Calgary and Lethbridge, Mount Royal University and MacEwan University and the Alberta Students' Executive Council.

While these funds provided innovative and vital services to students, improvements were necessary to ensure sustainability and equality for students across the province.

Over the next three years, the government has committed \$25.8 million, which represents a significant increase in funding to support post-secondary mental health in Alberta.

Advisory Panel on Post-Secondary Mental Health

Advanced Education established an expert advisory panel to develop recommendations for a long-term approach to post-secondary mental health funding and support.

The Advisory Panel included post-secondary students, faculty, staff, Alberta Health Services and the Canadian Mental Health Association.



Improving Post-Secondary Mental Health Next Steps

Next Steps

The Government of Alberta is taking steps to ensure Alberta's post-secondary institutions promote positive mental health and well-being, so students are prepared for success.

The next steps were informed by the work of the Advisory Panel and align with government's vision of an integrated, community-based health care system as demonstrated through the Alberta Mental Health Review Committee's recommendations.

The seven steps include:

- Providing equitable funding to publiclyfunded post-secondary institutions.
 - Consistent, annual funding directly to post-secondary institutions.
 - Support on-campus health promotion, wellbeing programs and training for staff.
- Defining roles of post-secondary and public health systems in improving post-secondary student mental health.
 - Working with government partners to clarify roles and responsibilities.
 - Post-secondary system manages health promotion and early intervention, while the health system will provide clinical care services.
 - Students will benefit from a more coordinated system that is accessible and easy to navigate.
- Integrating on-campus mental health supports with larger regional systems.
 - Regional student service coordination by post-secondary institutions, AHS, primary care, and others.
 - Community-based plans to address access to clinical services.
 - Three-year transition as integrated service plans unfold.

- Providing a one-time, two-year grant opportunity to support Indigenous postsecondary students' mental health.
 - Interim grant available to all institutions by application.
 - Allows Advanced Education time to thoroughly consult with Indigenous Peoples Post-Secondary Institutions, communities, and other stakeholders on appropriate long-term mental health approach.
- Funding Healthy Campus Alberta Community of Practice.
 - Students will benefit from consistent approaches and a strengthened postsecondary mental health system.
- Improving access to 24-hour universal supports throughout the province.
 - Work with Health, AHS and Children's Services to enhance the 24-hour crisis line, 211 referral service and web tools and better serve students.
 - Provide on-demand virtual 24-hour care to post-secondary students, regardless of where they study in Alberta.
 - Access will be available to all students, including distance learning students.
- Reviewing student aid policies.
 - Advanced Education is reviewing its student financial assistance policies and will consider how to support students experiencing mental health concerns.

The Government of Alberta is working with post-secondary institutions to implement these steps to promote and support mental wellness and build more resilient campus communities, so that students get the care they need.

Golden Bears & Pandas Legacy Fund

Last Thursday the 15th I met with the Director and Assistant Director of Athletics within the Faculty of Phys-Ed & Rec. We spoke about getting the ball rolling on the disbursement of the Golden Bears and Pandas legacy fund, a fee that all students pay to support student athletes.
